REV DR NAIM S. ATEEK is the founder and head of the Sabeel Ecumenical Liberation Theology Center, and former Canon of St George's Cathedral, Jerusalem. His major writings include *Justice and Only Justice: A Palestinian Theology of Liberation* (Maryknoll: Orbis, 1989)—generally recognised as the first book to articulate a Palestinian theology of liberation—and *A Palestinian Cry for Reconciliation* (Maryknoll: Orbis, 2008). He continues to lecture widely both at home and abroad.

PROFESSOR JAMES G. CROSSLEY is Professor of Bible, Culture and Politics in the Centre for the Social-Scientific Study of the Bible, St Mary's University, Twickenham, London. His two major research interests are the historical Jesus and contemporary constructions of the Bible in political discourses. His recent publications include *Jesus and the Chaos of History: Redirecting the Life of the Historical Jesus* (Oxford: Oxford University Press, 2015) and *Harnessing Chaos: The Bible in English Political Discourse since 1968* (updated edition; London and New York: Bloomsbury/T&T Clark, 2016).

PROFESSOR DAN COHN-SHERBOK is Professor Emeritus of Judaism at the University of Wales and Honorary Professor at Aberystwyth University. He is the author and editor of over 90 books, including many on the Israeli-Palestinian conflict and promoting Jewish-Christian dialogue.

DR RON DART has taught in the Department of Political Studies/Philosophy/ Religious Studies at University of the Fraser Valley in Abbotsford, British Columbia, Canada since 1990. His most recent book is *Canadian Christian Zionism: A Tangled Tale* (Dewdney: Synaxis Press, 2015), on former Prime Minister Stephen Harper (2006–15), Canadian conservative evangelicals, Zionism and the Palestinians. Ron was featured in the recent film on American Zionism, and the Palestinians, *With God On Our Side* and he has published two articles in *Holy Land Studies*.

DR MARK FINNEY lectures in the Department of Biblical Studies at the University of Sheffield. His teaching and research interests include religion and violence, contemporary aspects of religion and conflict in the Middle East (e.g., the Palestinian-Israeli conflict, Zionism, Christian Zionism, and the influence of the Christian Right in US foreign policy), and concepts of religion and the afterlife. He also has an interest in religion and art.

DR MARK GILFILLAN is currently a Research Assistant at the University of Edinburgh. In 2012 he completed a PhD thesis on the history of Edinburgh Jewry, 1790 to 1950. He is currently working on a project examining the history of the Church of Scotland's attitudes to Jews from the seventeenth century to the present.

PROFESSOR LESTER L. GRABBE is Emeritus Professor of Hebrew Bible and Early Judaism at the University of Hull. His research focuses on early Judaism and Northwest Semitic philology. His recent publications include *Ancient Israel: What Do We Know and How Do We Know It?* (London and New York: T&T Clark, 2007) and his four-volume work *A History of the Jews and Judaism in the Second Temple Period*.

DR MARY GREY has held academic posts in the Netherlands (Chair of Feminism and Christianity at the University of Nijmegen), Southampton (Chair of Contemporary Theology), and the University of Wales, Lampeter, (Chair of Pastoral Theology). She has a long association with St Mary's University, Twickenham, where she is Visiting Professor as well as being Honorary Professor at the University of Winchester. She has published extensively in the area of Liberation Theology, Ecology, and Social Justice. Her latest two books have focused on Israel-Palestine, *The Advent of Peace: A Gospel Journey to Christmas* (London: SPCK, 2010), and *The Resurrection of Peace: A Gospel Journey to Easter and Beyond* (London: SPCK 2012). She is a patron of Friends of Sabeel UK, a Trustee of Living Stones of the Holy Land, and Chair of their Theology Group.

DR ALASTAIR G. HUNTER is Honorary Research Fellow in the Department of Theology and Religious Studies in the University of Glasgow. He has taught and researched extensively in the field of Biblical Studies, with particular emphasis on the Psalms, the book of Jonah, and Old Testament wisdom literature. His most recent book is *An Introduction to the Psalms* (London: T&T Clark, 2008). He was President of UCU Scotland for three years to May 2007, and is currently national President of UCU, having served two years as vice-president with responsibility for Higher Education.

DR MICHAEL J. KOK received his PhD in biblical studies at the University of Sheffield under the supervision of Professor James Crossley on the early reception of the Gospel of Mark in the second century. His research interests include Jewish-Christian relations in the early centuries CE and the emergence of the Christian *adversus Ioudaios* ("Against the Jews") literature. His PhD dissertation has recently been published as *The Gospel on the Margins: The Reception of Mark in the Second Century* (Minneapolis: Fortress Press, 2015).

PROFESSOR AMY-JILL LEVINE is University Professor of New Testament and Jewish Studies, E. Rhodes and Leona B. Carpenter Professor of New Testament Studies, and

Professor of Jewish Studies at Vanderbilt University Divinity School and College of Arts and Sciences. Levine is also Affiliated Professor at the Woolf Institute: Centre for the Study of Jewish-Christian Relations, and co-edited *The Jewish Annotated New Testament* with Marc Brettler (Oxford: Oxford University Press, 2011).

PROFESSOR ILAN PAPPÉ is the Director of the European Centre for Palestine Studies at the University of Exeter and a fellow of the Institute for Arab and Islamic Studies. He was born in 1954 in Israel. He received his D.Phil from the University of Oxford in 1984. He taught in the University of Haifa between 1984 and 2006 when he moved to the University of Exeter. Among his books: *A Modern History of Palestine: One Land, Two Peoples* (2nd ed.; Cambridge: Cambridge University Press, 2003); *The Ethnic Cleansing of Palestine* (Oxford: OneWorld, 2006); *The Modern Middle East* (2nd ed.; London and New York: Routledge, 2010); and *The Forgotten Palestinians: A History of the Palestinian Minority in Israel* (New Haven and London: Yale University Press, 2011).
